



# NOTICE OF ELECTION

## Thursday 5 May 2022

### Wrexham County Borough (Wrexham constituency area)

1. Elections are to be held for County Borough and Community Councillors as listed below.
2. Nomination papers must be delivered to the Returning Officer no later than **4pm on Tuesday 5 April 2022**.
3. Nomination papers may be delivered to the Returning Officer, Election Office at the Guildhall, Wrexham, LL11 1AY between 10am and 4pm on any working day from the date of publication of this notice (excluding bank holidays), by appointment, or electronically as per the arrangements set out in the electronic delivery statement below.
4. Nomination papers may be obtained from the Returning Officer, either at the Election Office, or via [electoral@wrexham.gov.uk](mailto:electoral@wrexham.gov.uk). Nomination papers for Community Elections are also available from Clerks to the Community Councils.
5. If any election is contested, the poll will take place on **Thursday, 5 May 2022**.
6. Applications to register to vote must reach the Electoral Registration Officer by 12 midnight on Thursday 14 April 2022. Applications can be made online at [www.gov.uk/register-to-vote](http://www.gov.uk/register-to-vote).
7. Applications, amendments or cancellations of postal votes must reach the Electoral Registration Officer at the Guildhall, Wrexham, LL11 1AY by 5 pm on Tuesday 19 April 2022.
8. Applications to vote by proxy at this election must reach the Electoral Registration Officer at the Guildhall, Wrexham, LL11 1AY by 5pm on Tuesday 26 April 2022.
9. Applications to vote by emergency proxy at this election on the grounds of physical incapacity, for work/service reasons or the need to comply with an enactment or guidance from Welsh Ministers relating to coronavirus must reach the Electoral Registration Officer by 5pm on Thursday, 5 May 2022. The physical incapacity must have occurred after 5pm on Tuesday, 26 April 2022. To apply on the grounds of work/service or coronavirus, the person must have become aware that they cannot go to the polling station in person after 5pm on Tuesday, 26 April 2022.

An electronic read receipt from the Returning Officer is not confirmation that the nomination is valid. The Returning Officer will send a notice to inform candidates of their decision as to whether or not their nomination is valid.
